The camera was one of those that we "liberated", and shot was taken by one of Bill's four-man patrol. THIS PICTURE HAS NEVER BEFORE BEEN PUBLISHED. "History of World War II by Francis T. Miller. The junction of the American and Russian Armies was a symbolic event of vast import. 2nd Lt. Wm. D. Robertson headed the four-man patrol of the First Army's newest div., the 69th. The official junction was finally made in the city of Torgau on the Elbe. At 4:45 P.M. on April 25, Robertson crawled halfway across a wrecked bridge to be met by a young soldier of Marshall Ivan S. Konev's First Ukranian Army, Private Nicolai Ivanovitch Andreev." 4/25/45 Thanks.

History - On Sept. 29, 1943 the 777th Tk. Bn. was formed from units of 3rd and 11th Armored Reg. of the 10th Armed Div. at Camp Gordon, Ga. with Lt. Col. Ned T. Norris as Bn. Comm. Oct. 12, 1943, left for Fort Knox, Ky. On arrival there October 13th were assigned to the Armored Test Board. January 8, 1944 were relieved from duty with the Armored Board and assigned to the Armored School as Demonstration Bn. December 7, 1944 left Fort Knox for Camp Kilmer, N.J. with Lt. Col. David T. Zweibel, former Ex. Off. as Bn. Comm. December 16, 1944 board the SS EXPLORER and leave with convoy on December 17, 1944, dropped anchor in the Bay of Liverpool in dense fog. Docked on December 29, and on January 4, 1945 boarded trains for Wimborne Minster, Dorset, Eng. February 5, 1945 mount our tanks and depart for Port of Weymouth to cross English Channel. Debark from the LST at Le Harve, France, Feb. 6 and move to Camp Twenty Grand, Feb. 18, 1945 left for 300 mile trip to Belgium. February 20, 1945 arrived at Gomza Andaumont for duty with the First Army. Feb. 28 attached to the 28th Inf. Div. in the Hurtgen Forest for action at Schleiden, Sistig, Mulenhausen, Zingsheim March 17 Ettringen and on March 19 moved to Wassenach. on Laacher See and attached to the 69th Inf. Div. for the rest of the war in Europe, March 27, 1945 cross the Rhine River on the Victor Bridge to Honnningen and Bendorf to join the 69th Dausenau, Nassau, Bridge Weinahar on the Lahn River captured that afternoon. April 1, Wetzlar and April 3 & 4 Fritzlar and April 4 A. Co. reinforces 80th Inf. Div. in Kassel. April 5 to 9 Lutterberg, Landwerhagen, Witzenhausen Bonapart. Eichenberg, Hann Munden, Heiligenstadt. April 10 to 17 Kungen, Milhausen, Pettstadt, Weisenfels, Quisau, Galditz, Espenhein, Pagan. April 18 to 20 Liberwolkwitz, Leipzig, Eilenberg and the Mulde River, June 15 to 20 Liberwolkwitz, Leipzig, Eilenberg and, leave Leipzig by 40 & 8 for France. June 19 to 28 Camp Twnety Grand. June 30 leave from Le Harve on the USS Wakefield, July 6 1945 dock in Boston Pass through Camp Miles Standish on way to 30 day furlough August 14 to 21 reassembled at Camp San Luis Obispo. On the day the BN was activated both officers and enlisted men started calling it "THE LUCKY TRIPLE SEVERN" and that was

what everyone called it. The Bn. was deactivated some time during the last three months of 45.

We believe it is time to acknowledge the humanitarian acts of the American G.I. Currently there is a high degree of interest in the Holocaust, as evidenced by the great number of college students who elect to take course in this subject. If the story of the G.I.

were to be documented from first hand accounts, it will undoubtedly awaken a pride in our American heritage. At present volunteer researchers working at the center have undertaken this project. We are eager to contact as many ex-GIs as possible, from as broad a background as possible, to ascertain that our record is accurate. Did the members of your Org. serve in Europe during the spring of 1945? If so, we are appealing to you with several requests. Do you have a written account of the battles and of the camps which were liberated? Maps? Do you have a list of members whom we could contact to participate in our project? 
