

After the war, I took advantage of the G.I. Bill, and got a Master's Degree in Chemistry at St. Louis University. I am now Manager of The Department of Chemical and Physical Testing for Owens Illinois, at Toledo, Ohio.

One thing I am curious about. I transferred to the 269th from F-Co., 273rd Regiment. While in the Infantry, I qualified for the Infantry Badge, but never received it. This was not important at the time, but after the war, when people were being sent home according to the number of points they had, the lack of having this badge made it necessary for me to stay in Germany longer. I did not come home with the 69th. I was in Paris on a pass, and when I returned the 69th had gone home, and I was shuttled around Germany, until I had enough points. Anyway, the loss of the badge and the rifle insignia, indicating combat, has ticked-me-off for years. My question is, can I get the badge now? I'll never wear it, but I earned it the hard way.

That's all for now, and best wishes to the organization. Maybe, some day, I'll make one of the Reunions and re-live old times. I have many pictures taken in Shelby and Europe, and they might be interesting to some of the men.

Needless to say, there were no women in town. Laughing about the long lines of shots . . . sore arms . . . first time trying to put on leggings . . . putting up pup tents for the first time . . . inspections . . . guard mount . . . drill and hikes. Most of all it was the Camaraderie or Buddies getting together . . . and no matter how many years have passed, that deep intense feeling of young lads, who became soldiers and served together under extremely adverse conditions, welded us together, and permanently to remain "A Great Legion of Men" who can look each other in the eye and say . . . "Buddy.'

Unfortunately, some of the group are not in the best of health, but in spirit absolutely tip-top. There were some serious moments also, such as, we are all appalled by the attitude of the young people today. Our President Comes Into Your Home Again

Hello, Again!

By the time this Bulletin reaches you, the New Orleans Reunion will be just around the corner. From early reports from **Paul Shadle**, it appears we will have a great turn-out, and **an outstanding Reunion**.

In keeping with my desire to keep all of our members informed, I can report that many of our members have worked hard to accomplish the following of interest to us all:

1. Reunion detail planning and work force in New Orleans is all set with only final reply from the Honor Guard for our Memorial Service outstanding. I am awaiting a reply from the Adjutant General of the National Guard in Louisiana.

2. The recommendations of our Resolutions Committee for up-dating our Constitution and By-Laws appear elsewhere in this Bulletin. These matters will be offered the entire membership for consideration and appropriate vote in New Orleans.

3. The Committee for Consideration of the Future of Our Scholarship Program, continues to seek comments and recommendations from all our members, to incorporate in their considerations and/or recommendations in New Orleans.

4. Our Scholarship Chairman, Sam Woolf, met with his committee on May 18th, to select winners to be announced in New Orleans.

5. The proposal by the Hq. 7th Army Staff Officeer to re-designate the Berlin Brigade as the Fighting 69th, continues to be staffed at DA level. General Bolte is monitoring this action.

6. I am in receipt of a recent Staff Proposal whereby all records of military personnel excluding outstanding persons, will be destroyed 75 years following their discharge, separation or retirement. At New Orleans, I submit that we prepare a reply in behalf of our membership on the proposal. General Bolte joins me in a strong feeling . . . we should not approve.

On the matter of Board Members to be elected at New Orleans: I solicit recommendations from each of our Regiments, Divarty, Special Troops, 661st TD's, 777th Tank Battalion, 269th Engineers, for the member of their unit recommended. Those recommended should be members who attend Reunions with regularity, which includes many of our faithful who have never before had the opportunity to be involved and serve.

FUTURE REUNIONS—We must plan ahead to ensure proper detailed planning toward the selection of future Reunion sites. It is important for us to know and publish the next two to three sites selected. Any proposals for future Reunion sites must be supported by a minimum of details worked out in advance, between the member(s) submitting such proposal. A basic guideline is available by return mail, for those who request it from me. For our 1981 Reunion, we will go to the Host Inn, in the Dutch Country, near Harrisburg, Pennsylvania. Bill and Betty Foster are Chair-persons for this Reunion, assisted by the Central Pennsylvania Group. For 1982 and 1983, no sites have been determined. I am hopeful we can arrive at these decisions in New Orleans. I am currently aware of the following site recommendations that will be offered with detailed information:

- 1. Mountain Shadows, Scottsdale, Arizona.
- 2. Marriott Marco Beach Resort Hotel, Marco Island, Florida.
- 3. Marriott, Orlando, Florida (Near Disney Land, Sea World, etc.).
- 4. Marriott, St. Louis, Missouri (2 facilities).
- 5. Milwaukee, Wisconsin.

6. Hopefully from someone in the area of Valley Forge, Pennsylvania. Finally, on Reunion sites: we gain a whole lot in resort type amenities when we meet at the super resort places in their off-season. Likewise, we pay the most for the least, when we meet at a facility during their peak seasons. Thus, we might start to look at later fall dates in Northern and NE areas.

I am sure your ideas and thoughts generated into his mind, along with the Board Members, will make for a better Association for years to come].

Resolutions/By-Law Amendments

Your Resolutions/By-Law Committee has been working for a year now, trying to up-date our By-Laws to make it fit the times, for over the years things do change. The committee would like to make as many of the following changes as time will permit in New Orleans, and has asked all members to read them for your consideration in New Orleans. Especially, those members who are planning on being in New Orleans, do study them out and compare with the By-Laws you should have, which were published in an earlier edition of the Bulletin . . . so that your thoughts can be included.

Knowing that it will take several years to really adjust and bring the By-Laws to where they should be, our committee has recommended the following:

- 1. There is a real need to spell out the allocation of Complimentary rooms at reunions.
- 2. A By-Law is needed that requires the Reunion Chairman to turn over to the Treasurer all monies collected at the end of each day of the Reunion. Further, that the Treasurer shall make proper record of this money, which shall be deposited each day to our account with the Reunion facility, for safe keeping. Finally, that final settlement with the Reunion facility be completed in no less than 5 days following conclusion of the Reunion.
- 3. In absence of written records of matters voted for in previous Reunions, it is suggested we take action to ensure that those matters we can recall be made a part of our Constitution and/or By-Laws, in a proper manner and duly recorded. For example, we voted at Lake Wright in Virginia, to pay for Clarence Marshall's room. Also, we voted in the past to extend Scholarships to grandchildren, adopted children and foster children. I'm sure other items previously approved by General Meetings can be recalled, and merit confirming or reconsideration actions .duly recorded:
- 4. There is a strong membership demand to review our Scholarship program and its future.
- 5. We need to spell-out those appointments to be made by the President.
- 6. There is need to review and up-date our Constitution and By-Laws in the following areas:

a. Do we want 6 or 7 Board Members each year: Article IV.

b. Are officers elected for one or two years? Article V.

c. By what authority — and do we need a Chairman of the Board?

d. Should not **all** Past Presidents be official, voting and recognized Life-time Members of the Board. Article I, Section 4.

e. Why do we need an Executive Committee? Article VI.

f. The quorums in Article IX needs review. We will vote on a new Board quorum in New Orleans.

g. How long since we have had a chairman of Standing Committees — Do we need one? Article II, Section 4.

7. The word **Convention** should be entirely eliminated, whereever it appears in the Constitution and By-Laws. It is not a Convention but a **Reunion**.

8. Article III, [a] Active Members:

Paragraph 1: "Upon the death of an active member, his membership shall be available to his heirs of blood relation. We have eliminated "or her" in two places in that one sentence. We had no females in the 69th Infantry Division, therefore, "or her" is not applicable.

Article III, Sub. Paragraph [b] Honorary Members:

2nd Paragraph reads: "Honorary Members have not the right to vote, pay dues or hold office."

This should read: "Honorary Members do not have the right to vote, nor hold office." The paying of dues may be done on a voluntary basis, which would insure their receiving a Bulletin.

Article III, Sub Paragraph [d] Associate Members:

The Board of Directors of the Association would be authorized to approve the sons (of members of the 69th Division Association) as being Associate Members of the 69th Infantry Division Association. Associate Members do not have the right to vote, nor hold any office, but are required to pay yearly dues.

9. Article IV

The Management of the Association shall be by a President, Vice-President, Secretary, Treasurer, and a Board of Directors (not to exceed eighteen); in addition to the other members of the Board. The Past Presidents of the Association shall be members of the Board ex-officio.

10. Article V

[a] Now reads: "One Year."

We propose: The Officers of the Association shall be elected by the members at the Annual Meeting, and shall hold office for two years, or until their successors are elected and qualified.

By-Laws of the 69th Infantry Division Association, Section 3:

The Secretary shall be a member of the Board of Directors. The duties of the Secretary are administrative. He should be efficient and well informed.

The Secretary makes and keeps a record of all business transacted at each meeting at the Reunion. The Secretary should have a copy of the Constitution and By-Laws. Upon completion of his term in office (two years), the Secretary should transfer all of his secretarial records to the incoming Secretary.

11. Article I, Section 4, Treasurer

The Treasurer should be a member of the Board of Directors. He shall receive and receipt for, and be custodian of all funds of any nature whatsoever due the Association, and such contributions as may be made to it, and deposit same in the name of the Association in a bank or banks, or a trust company or companies, to be designated by the Board of Directors. He shall draw checks in payment of all bills and claims against the Association, when such bills and claims have been certified to him by the President. He shall employ such clerical assistance and other personnel for and on behalf of the Association as may be necessary, subject to the approval of the Board of the Association. The Treasurer's duties shall begin at the conclusion of the Reunion at which elected, and shall furnish such bonds as may be required by the Board of Directors, the premium of which shall be paid from the funds of the Association. He shall make an Annual Report at the Reunion. The Treasurer should receive from the Reunion Chairman, all monies collected at the end of each day of the Reunion. The Treasurer shall make proper record of this money which shall be deposited each day to our account with the Reunion facility for safe keeping. The Treasurer shall make final settlement with the Reunion facility to be completed in no less than five (5) days following the conclusion of the Reunion.

12. Board of Directors, Section 5

The Board of Directors shall consist of the President, Vice-[Continued on Page 9]

President (not to exceed three), the Secretary, the Treasurer and those members (not to exceed eighteen), elected by the membership. The Board of Directors should consist of one member from each of the following Units: Division Special Troops, Division Artillery, 269th Engineers, 271st Infantry Regiment, 272nd Infantry Regiment, 273rd Infantry Regiment, one from the 661 TD or one from the 777 TD. The Board of Directors, during the interval between Reunions, shall carry out the policies adopted by the Association. The Board of Directors shall have authority to call a special Reunion of the Association by a majority vote of the Board. The Board shall have authority to designate the time and place of each Annual Reunion. The Board shall have authority to set the amount of membership dues.

13. Article II, Section 2, Nominating Committee

The Nominating Committee shall consist of not less than seven (7) members to be appointed by the President and shall include one (1) former member of each of the following Units: (1) 271st Infantry Regiment, (2) 272nd Infantry Regiment, (3) 273rd Infantry Regiment, (4) Division Artillery, (5) Division Special Troops, (6) 269th Engineers, (7) 661 TD or 777 TD.

[Editor's Note: Board Members read, make notes, and be ready to express your opinion on subject changes from the Committee, as time will be limited at the Reunion, and I am sure we also want to enjoy ourselves in New Orleans.

Fellow members, since we usually only have a two to two and one-half hour General Membership Meeting, if there are any By-Law changes you wish made, express your feelings to a Director so that he can bring them up at one or both of the Board Meetings to be held this year at our Reunion. These Board Meetings will be held on Thursday and Friday afternoons.

I believe Chuck Herring, Chairman of this committee, will have a committee meeting earlier in the week for his crew].

In talking to Sol's brother he informed me that on the very day he died he kept talking about his Buddies in the 69th. This was very typical of Sol. When **Morris Yegelwel** and **Sonny Baron** visited Sol, after his first leg amputation, he kept talking about the 69th and all of his Buddies.

Sol had never forgotten, and was very proud to be a Sixty-Niner.

Last week Sol had to have his other leg amputated and I guess that was just too much. He suffered a cardiac arrest.

If you look back on the History of the 69th you will find not only that Solly was a Past president of the National Organization, but also one of its Charter Members. I feel Solly did more for the 69th than any man in the organization. I will certainly miss him, and I know all who ever came in contact with him, will miss him.

A Sentimental Journey Back to 1945 Europe

We flew to Brussels this past July, and toured the charming medieval towns of Ghent, Bruges and Ostend. Then, we drove to the Malmedy battlefield area, where we visited a family I had last seen in 1945, during the fighting in World War II. My 69th Infantry Division machine gun Infantry squad stopped at a cobblestone (ca. 1775) barn and farmhouse during a snowstorm. Several families were huddled there, since their houses had been destroyed earlier. My buddies and I slept in the hayloft above the cows and we spent several days there chatting in French and German, with the families in this French-German border area, before moving forward into the German Seigfried line.

On this return visit, their seventeen-year old daughter, now fifty-one years old, greeted us and introduced her husband (a former Italian soldier liberated by the Russians eventually), and their four daughters (aged thirteen, sixteen, seventeen and thirty). The aged owner was there to remember, and to greet us. I brought my descriptive V-mail Army letters which my Mother had saved, and they were translated into French that day by a doctor-nephew caring for his ailing uncle, as we sipped tea. We then toured the former battlefield area, now a beautiful, national park with hundreds of vacationers (with camper vehicles or brilliantly colored tents) all enjoying the beauty of the woods and lakes.

We then accompanied our friends as they attended a local wedding at City Hall, followed by a lovely church ceremony, and a wedding reception afterwards. We were the unusual out-of-town guests, as we enjoyed the dancing, including a mixer where dancers join a large circle and a couple moves to the center to dance, bow low and kiss. Lots of drinking and dancing to continuous recorded music of folk, rock, disco, jazz and fox-trot, till midnight.

From Belgium, we drove through the vineyards and wine country of Moselle Valley, and into the castle area along the Rhine, which I saw during fighting into Germany. We also saw and visited the French chateaux country in the Loire Valley. But, we also made an important visit to Dachau.

Located 10 miles outside of Munich, Dachau was a pleasant resort town in 1933, when the Nazis established the notorious concentration camp on the edge of town, to handle "objectionable people for dispersal to other places.' About 40,000 people were killed there and memorialized by monuments and plaques from Jewish, Catholic and British groups (Four British women soldiers were brutally killed by their Nazi jailers).

Liberated by U.S. troops in 1945, the site was preserved with the walls, barbed-wire and gas chambers, remaining intact, and two of thirty barracks were rebuilt along with the administration building which is now a museum, documenting the Nazi horrors. The site is now called a "Place of Memory." It was hard to find any directional signs to the camp location on the edge of the town of Dachau, as the Germans don't consider it a proud attraction. I said a prayer at the Jewish memorial, and then spoke to an older German woman, who expressed sadness that very young people were not interested in this part of German history. (Young people have been impressed by "Holocaust," however). An interesting eerie feeling overcame me as we completed a tour of the gas chamber area. At five o'clock, the gates were locked and our group had ten anxious minutes waiting behind barbed-wire while the German guard was located to unlock the gate to free us from Dachau.

The Late Edward R. Murrow Broadcasts From Germany Sunday, April 22, 1945

The following was broadcast nationwide by the late CBS Correspondent, Edward R. Murrow, from Germany on Sunday, April 22, 1945-

"Tell them resistance was slight" . . . that's what a G.I. shouted to us as we entered Leipzig. There were two tankers dead at the corner. Somebody had covered them with a blanket. There was a sniper working somewhere in the next block. Four boys went out to deal with him, and then there was silence. The Gestapo Headquarters had been evacuated in a great hurry, but they had taken all of their files with them. Down in the Air Raid Shelter the floor was covered with money ... Belgian ... Polish ... Hungarian. Wherever the Germans had been the money was ankle deep . . . and it was dirty . . . and had no meaning. The Germans were fighting for a bridge. They were doing what they have done for many days . . . firing off a few bazookas . . . killing a few boys . . . and then surrendering. There is no desperation about this German defense . . . they shoot till they are about to be killed . . . and then they give up. I have seen them do it at Leipzig and Nuremburg. But, let me tell you about the taking of Leipzig, and the town hall. At sixteen forty-five, on Wednesday, they lined up the tanks and the boys draped themselves around them. They were part of the Sixty-Ninth Division. It was about a thousand yards to the city hall. There were one hundred and eighty-five men on the outside of the tanks. They started down the street . . . there were thirteen tanks and five tank destroyers. They were in columns moving down a single street. When they began to roll they were hit with bazookas, and machine guns. When they turned the corner the wounded slipped off. The medium tanks were traveling about thirty miles an hour, and no man turned back. Lt. Ken Wilder started with a total of thirty-nine men and when he reached the city hall they had eight. They had a company of infantry riding on the tanks, one hundred and eighty-five men. Sixty-eight reached the city hall. The tanks were marked with machine gun fire, and they were splattered with blood. An hour after reaching the city hall, those boys were driving German cars and motorcycles about the streets. They had done some looting in city hall, mostly stuff they could drink, or use. We were sitting outside and a sniper's bullet broke a pane of glass in a window. A doughboy said "My, My, somebody done broke a window." "Things are getting rough around here . . . folks are destroying things."

The Germans had given up. A few had shot themselves. One said he couldn't be taken prisoner by the Americans, and he must commit suicide. A young lieutenant said there's a gun, and he slipped the clip out of a forty-five. The German took it and shot himself, just under the right ear.

In the basement of the city hall, German civilians were looting food. The underground rooms were filled with rifles, grenades, bazookas, food and wine.

The day we took Leipzig, there was a fairly stiff wind blowing and the air was filled with dust, heavy red-brick dust, that filled the eyes and nostrils. The shelling had caused no fire, as there was nothing left to burn. The city had been killed by bombings and it was merely a dusty uneven desert. Not far away in Leuna, there is another kind of desert, acres and acres of twisted rusted pipe, huge tanks ripped open, steel girders pointing to the sky. Leuna was the greatest petroleum plant in Germany. I have just been looking at some dusty notes made in Leipzig. The names of some of the boys who were in that thousand-yard dash down streets that they named suicide alley: Lt. Arch Farrar of Sommerville, Georgia, who was in the lead tank. He had twenty-five left out of thirty and thought himself lucky. Staff Sgt. John Fitzgerald from Chicago said he wished his wife knew he was O.K. He hadn't had much time to write, what with fighting and traveling.

The Germans in Leipzig were beaten, but their bullets killed men just as though they were not beaten. As this war rolls forward, it would be well to remember that.

Days of Remembrance

By Francis T. Tomaczuk

I visited the Auschwitz Concentration Camp in Oswiecim, Poland, on three occasions. Each time was more depressing than the previous. This museum, maintained by the Polish government as more than a reminder of man's bestiality to man, should be visited by everyone going to Poland.

It is not pleasant. It is bare. The buildings are close together, but the areas between 'streets' are wide.

"Arbeiten maks frei" reads the entrance sign. I walked through, slowly, and read in many places the haunting names of those whose blood blessed the ground on which it dropped. I thought of the Blessed Maximillian Kolbe, who gave his life for a man who still lives. I saw the eyeglasses, the valises, the false teeth, the small possessions taken from Christians and Jews who were deprived of humanity before they were slowly and agonizingly put to death.

I looked. In a small cell I sat as a prisoner would, unable to stand. I know how lucky I was to live in a land of freedom. Other people left, and my thoughts went back many years.

It was a day in April 1945. Somehow my friend and I, separated from our forces by enemy action, joined a British group. In a few days we were to meet the 58th Russian Division at the River Elbe. But now, we, members of the 271st regiment of the 69th Infantry Division, came with some British troops to a small town, and then, to a place my mind will never forget because of what my eyes saw, my ears heard, and my mind wept for.

Buchenwald, Buchenwald Concentration Camp.

Tall men, weighing less than 90 pounds; women, shapeless, gaunt, sallow-complected; children with expressions that saw death not life. Grim allied soldiers.

We talked with the prisoners, most of whom were Polish. Many were Polish Jews. Many were Polish Catholics. Many were Polish Protestants.

I shared my lunch, which calmly they divided equally. (I still remember the same group fighting over a dropped cigarette butt). They talked of their families, hoping their wives, their children, would still be alive.

With them as guides we 'toured' the place. The Nazi bums were under guard. The conscienceless men and women were still insistent upon receiving their rations of food, but the food master sergeant somehow seemed to remember how to ration food the way the prisoners had received their daily meager ounces.

We saw lampshades made of human skin. We were told and saw pictures of experiments, in which women had their calves cut away to be sewn onto other' legs.

We talked to a survivor who was forced three times to jump naked into a pool during winter. When he and others became exhausted, they would be pulled out, warmed, fed, and brought back to normality. Then the very respected German doctors would repeat the experiment. Several died the second time; more the third time. This man did not die because the fourth experiment could not be held. The pool had frozen into ice.

When prisoners arrived, they were given examinations. Those with gold teeth had them extracted, without novocaine. Gold rimmed glasses were taken. Rings were taken and fat fingers were lost if the ring would not come off. Recalcitrant prisoners were put into small cells where they would starve to death. Others were put into pits, from which they would be dragged up by sharp piercing spikes, put on a slab, and while still alive but muscularly helpless, slid into a furnace, too weak to cry out in even feeble protest.

A lament was told. "A woman with a precious baby in her arms was told to keep the child quiet. She tried. She even put her hand over the child's mouth. Then she pleaded with the Nazi. It was her blunder. The prisoner who told me the story said, "The guard yelled at her, called her vile names. Then he said, 'If you can't keep the bastard quiet, I can,' and with his club, beat the child on the head, killing it instantly. The woman went crazy, and no one could take the child from her. It was the last I saw of her. I hope they killed her, but they may have let her be alive so that she would grieve while they laughed. You should kill the Nazis now today."

We saw a gas chamber. When too many arrived for the housing — six deep above on bed space, and two in a single bed — they were told to undress and take showers. Mothers were forced to be naked with male children. Then they were led to the Cyklon chambers, and met merciful death.

In one of their most bestial tortures, sons were given guns with one bullet and told to shoot their mothers or fathers. To induce them to do so, they were placed onto electric connections to their most intimate parts. Shocks were induced, extremely painful, yet not painful enough to bring unconsciousness.

We went outdoors. A team of British doctors had arrived.

Beside a large trench, more than 1,000 cadavers were placed, like so much timber piled up. A bulldozer come noisily, ready to push the bodies into a common limed pit.

The British doctors, however, stopped the procedure. They insisted that every single body be given a death certificate. Chaplains prayed. Thank God! Among the more than 1,000 cadavers, some thirteen were found to be still alive.

A few days later we learned that General Dwight D. Eisenhower, Commander of the Allied Forces, forced all able bodied Germans, regardless of age, to walk through the Buchenwald and other concentration camps.

Indeed, we saw how the Germans were affected. Many cried. Many cursed Hitler, bringing them to the shame of the world. In orderly groups, many women prayed the rosary, kneeling for the Our Father and ten Hail Marys, and saying all thirty parts of the Rosary.

The Germans were subdued by their guilt.

Many of the prisoners were now released. Some, lucky to be alive, had not had a bath for two years. Their toilet needs, they said, were a two-minute time allotment daily. There had been no toilet paper.

The American Army (the best in the world) set up large air tents into which they installed showers. However, the Poles, Frenchmen and Russians refused to enter, being afraid of being gassed. As one of the volunteers, speaking Polish, some Hungarian, and very little Russian, I had to undress and naked lead a group into the showers. They luxuriated in the hot water, the smell of clean soap. I took no less then ten showers that day. When we all left the tent, fresh clothing was theirs. GI laughter and my 'old' uniform was mine.

Russian ladies had advice for the Americans: Attack Stalin now and the whole Russian army will go against him. He is as despised as Hitler.

The roads are filled with Poles, Russians, Frenchmen, Hungarians . . .

"Are you all right, sir?" asked a Polish guard. Again I was back in Oswiecim. Slowly I rose and went to the exit.

How Poland suffered. How mankind suffered, just because someone did not care for the rights of man. If the Polish Army had not fought Hitler's Third Reich, there would not be a Jew alive in Europe today — nor any other free man...

Ernest W. Jackson Served in B-Battery 880th Field Artillery Writes...

I was drafted in Jacksonville, Florida, in May 1943, and was sent to Camp Blanding, about 40 miles from there, for

induction. Then, I was sent to Camp Shelby and joined the 69th, in May 1943. I was at Camp Shelby with the 69th for about 18 months, and went to England in December 1944, with the 69th. I stayed with the 69th until we met the Russians on the Elbe River in Germany.

I was sent back for an operation right after that. My lip had become infected with a skin cancer from the sun. I was six weeks in leaving England for the states, but finally got a hospital ship for the states. It only took the ship four days to cross, where, when we went over in convoy, it took us about fifteen days. I landed at the same base (Camp Kilmer), which we had left from. We got on a hospital train and went to a hospital in Okmulgee, Oklahoma, but after two weeks there, they decided I didn't need a bone hospital and sent me to another one at Hot Springs, Arkansas. They gave me a thirty day leave and I reported back to Hot Springs, where after two weeks I had the operation. It took me several weeks to recoup. and they gave me a forty-five day leave and said that I should report to an Army Post in San Antonio, Texas.

I worked there for about three months, figuring Army payrolls. While I was there the Captain made me a Sergeant, (I was one of the few who were never a P.F.C., having gone from a private to a gunner Corporal, two weeks after I had been in the army). After I had been there for about three months, I was transferred to a German P.O.W. Camp at Ft. Bliss in El Paso, Texas.

I stayed there for about a week and went to a side camp that had about 200 P.O.W.'s there. I was a Buck Sergeant, but I acted as 1st Sergeant at the side camp. We had about fourteen enlisted men and a Captain besides the German P.O.W.'s. I stayed there for about three months and got enough points to get out. I went back to the Fort in El Paso and got discharged.

I went to my home in Jacksonville and back with G.M.A.C. After working in Jacksonville about three months, I was sent to Thomasville, Georgia, on July 1st and stayed there until the last of 1947. I married a Thomasville girl while there. We went to Jacksonville the latter part of 1947, and worked there for about five or six months and we were sent to Albany, Georgia, in 1948. I have been in Albany since then, except for about seven years when I was in Waycross, Georgia, from 1955 to 1963. I have three children; a girl who is thirty-one, married and lives out in Tucson, Arizona; a boy who is twenty-nine, married and lives in Dawson, Georgia; and a boy who is twenty-three and stays with me all the time. I had a stroke in 1975.


